2023 Terms & Conditions

Applicable Law: All horses are offered for sale pursuant to the laws of the Commonwealth of Virginia. There are no warranties or guarantees as to the fitness for any particular purpose(s) of any horse offered in this sale. Every effort will be made to document unsoundness or vices and all negative factors (health, disposition, management, etc.) on all animals in the sale and such records will be made available for review prior to the sale. Bidders are cautioned to examine records and horses closely before bidding and purchasing. Owner or any representative thereof shall not be responsible for any oversight of a fault. All horses are sold on an as is and where is basis. All horses are sold "caveat emptor" (buyer beware). All sales are final and absolute. No refunds will be given for any reason.

Pre-purchase Inspections/Examinations: Prospective buyers who are encouraged to inspect, examine, and research sale horses of interest before submitting a bid. Such inspections or examinations will be completed at the prospective bidder's expense, by a licensed veterinarian of bidder's choice, if so desired, and by appointment only. Pre-purchase exams must be conducted prior to the auction, by appointment only, and in the presence of Natalie Duncan, Equine Center Manager. Pre-purchase inspections must be completed no later than Tuesday, October 24th. Procedures to be performed during the exam must be approved in advance. No flexion tests will be permitted on horses two years old or younger without permission. Pre-purchase exams must be conducted at the Smithfield Horse Center and horses must be handled at all times by Virginia Tech employees or agents thereof. Prospective buyers and anyone accompanying them are cautioned to be extremely careful while on the grounds examining the horses. No stall or paddock entry shall be permitted without staff assistance.

Bidding Procedure: All prospective buyers who are interested in purchasing a horse must be registered as a bidder. Registration as a bidder commits the bidder to purchase any horse for which he/she has the winning (high) bid. The online bidding will close promptly at 6:00 pm on Friday, October 27th. No bid will be valid after 6:00 pm on Friday, October 27th, **unless a bid is placed by any bidder within 5 minutes of the auction closing. If this occurs, the auction will be extended by an additional 5 minutes. This will continue until there are no new bids made within a 5-minute window. At that point the high bidder will be awarded the horse.**

Assumption of Risk: The buyer, at the close of bidding, shall assume all risk and responsibility for the horse. All horses purchased must be removed from the premises within 14 days from the end of the online bidding. During the stay of any horses on the premises during this time period, students shall continue to provide all normal care for the animals. However, neither the seller nor any Virginia Tech employees, officers, agents, or representatives thereof shall be responsible or liable for any accidents, disease, death or injury to any horse or any person, facilities, or equipment. Horses sold are accustomed to traveling untied in a box stall in a fully enclosed stock trailer. Consequently, it shall be the buyer's responsibility to provide suitable transportation for purchased horses. Virginia Tech employees, officers, or agents will be available to assist with loading of horses, but will not be responsible or liable for any accidents or injuries to animals, persons, or equipment during or after any horse is loaded onto a trailer. Assistance will be available to assist with loading of horses is loaded onto a trailer.

Sales Conditions and Payment: All sales are final. Purchasers may not stop payment of a horse for any reason if they are the high bidders at the close of bidding. However, if for any reason the high bidder chooses not to make payment and take the purchased horse, a non-refundable \$500 rehoming fee will be charged to the high bidder and the horse will then be offered to the next highest bidder at their last price prior to the winning bid. If that bidder declines to purchase the horse, it will then be offered to the next highest bidder at their last price prior to the second highest bid. In the event that the horse is not sold, the rehoming fee paid will be used to pay for the care of the horse. In the event that the horse is sold to the second or third highest bidder, the non-refundable rehoming fee paid will be used to pay for other horse program costs in general. Sales tax in the amount of 5.3% will also be collected from Purchasers unless they are exempt and provide exemption documentation.

Liability: Neither Virginia Tech, the Virginia Tech Foundation, Inc., nor any employees, officers, agents, officers, students, or volunteers shall be responsible or liable for any injury, death, or damage of any kind to any person or animal. The public is not allowed in any stall, paddock, or pastures without permission. Horses must be handled at all times by employees or agents of Virginia Tech. Examinations of horses are conducted at one's own risk. The public is cautioned to be verv careful while on the grounds examining horses and particularly while horses are being handled, ridden, or driven.

How to Place A Bid

- 1) Bidding opens on October 13th. Create a buyer account at **horsesales.cals.vt.edu**. Don't forget to write down your password as you'll need it for every log in! Use an email account you will frequently check as that is how you receive notifications about counterbids.
- 2) You have the option to place a single one-time bid, or place a maximum bid. All bidding occurs in increments of \$100. If you enter any value not in a hundred dollar increment, your bid will be rounded UP to the nearest hundred dollars at the end of the auction.
- Remember that the bid price does not include the 5.3% sales tax that is added to the final bid price (unless you have tax exemption status).
- 4) Bidding ends at 6pm on Friday October 27th. However, if a bid is placed within the last 5 minutes for an individual horse, that individual auction close time will now extend another 5 minutes to allow other bidders time to log in and adjust their bid if desired.

What is a proxy bid? Bidders have the option to set a maximum price they are willing to spend. The system will *automatically* bid for them against other bidders in \$100 increments up until that value. If your maximum is outbid, or a higher proxy bid is placed by another bidder, the bidder is notified by email and may set a new proxy bid if desired. You may not adjust your maximum bid UNTIL you have been outbid.

For example: The next bid price is currently \$6,500. If I place a maximum bid of \$12,000, the next bid price is now \$6,600. If someone else places a max bid of \$9,000, the next bid price automatically jumps to \$9,100 to outbid their maximum bid and I stay the top bidder. If someone places a max bid price of \$13,00 the next bid price jumps to \$12,100 and I'll be notified that I have been outbid.

For example: If I place a bid on Brie at 5:59 on 10/27, the auction for Brie will now close at 6:04pm. If someone else places a bid at 6:03, the auction now closes at 6:08pm.
